**Approval of the City of Avalon proposed allocation of Fiscal Year 2022-23 Community Development Block Grant (CDBG) funds, Re-Allocation of the balance of FY 2021-22 CDBG funds.**

### **The Council will consider the following proposed allocations:**

The use of \$71,000 reserve and \$40,000 Fiscal Year 2022-23 CDBG funds for Phase II of the City-Wide ADA Curb and Ramp Project for a total project cost of \$111,000.

The estimated FY2022-23 CDBG annual allocation for the City of Avalon is \$40,000 and may fluctuate by +/- 2%.
